- a year end cash book summary in support of Section 2
- a year end bank statement for one of the bank accounts to support the bank reconciliation to Section 2, Box 8. These were requested as part of our intermediate review procedures. The bank statement provided for the Treasurers Account – Mayor's fund was dated 30 October 2017.
